4. THE ARTS: WE OFFER PROGRAMS DESIGNED TO DEVELOP CLUB MEMBERS CREATIVITY AND CULTURAL AWARENESS THROUGH KNOWLEDGE AND APPRECIATION OF THE VISUAL ARTS, PERFORMING ARTS, CREATIVE WRITING, CRAFTS, AND MORE. EVERY LOCATION HAS AN ARTS ROOM WHERE CLUB MEMBERS PARTICIPATE IN FREE CHOICE ACTIVITIES AND STRUCTURED PROGRAMS. ADDITIONALLY, WE PARTICIPATE IN THE BOYS & GIRLS CLUBS OF AMERICA NATIONAL FINE ARTS COMPETITION ANNUALLY.

5. SPORTS & RECREATION: WE OFFER ACTIVITIES AND PROGRAMS DESIGNED TO ENCOURAGE PARTICIPATION IN PHYSICAL FITNESS ACTIVITIES, SPORTS AND RECREATION. CLUB MEMBERS HAVE ACCESS TO GYMS, LEAGUES, AND PROGRAMS THAT EQUIP THEM LEARN ABOUT ACHIEVING INDIVIDUAL AND TEAM RELATED GOALS. EXAMPLES INCLUDE: ALL STAR SPORTS (BASKETBALL, FOOTBALL, AND CHEER) AND TRIPLE PLAY (FOCUSED ON STRENGTHENING THE BODY, MIND AND SOUL).

AT THE ONSET OF THE COVID-19 PANDEMIC IN MARCH 2020, WE OPENED ONE CLUBHOUSE SITE FULL DAYS (8AM-6PM) IN ORDER TO MEET THE NEEDS OF WORKING FAMILIES AFFECTED BY SCHOOL CLOSURES. AS OF MAY 2020 WE OPENED THREE MORE SITES AND ALL SIX WERE OPERATING BY JUNE 2020. FOR THE 2020-2021 SCHOOL YEAR, OUR CLUBHOUSES WERE OPEN ALL-DAY (VERSUS ONLY AFTER-SCHOOL) IN ORDER TO CONTINUE PROVIDING ACADEMIC SUPPORT FOR YOUTH ENGAGING IN REMOTE/DISTANCE LEARNING. PRECAUTIONS TAKEN TO ENSURE THE HEALTH AND SAFETY

OF STAFF AND MEMBERS INCLUDED FREQUENT CLEANING/DISINFECTING OF ALL CLUBHOUSE COMMON AREAS, LOWER STAFF-TO-YOUTH RATIOS, STRONGER SOCIAL DISTANCING MECHANISMS IN PLACE, AND MORE. WE ALSO LIMITED IN-PERSON ATTENDANCE TO A MAXIMUM OF 60 YOUTH PER CLUBHOUSE AT ANY GIVEN TIME AND PRIORITIZED CHILDREN OF FIRST RESPONDERS, HEALTHCARE STAFF, AND OTHER ESSENTIAL WORKERS IN OUR COMMUNITY. THROUGHOUT THE PANDEMIC, WE WERE COMMITTED TO: PROVIDING ACCESS TO HEALTHY MEALS AND SNACKS FOR CHILDREN WHO HAVE TYPICALLY RELIED ON THE BREAKFAST AND LUNCH PROGRAMS AT SCHOOL; ENSURING THAT OUR RE-OPENED CLUBHOUSES FOLLOWED STRICT HEALTH AND SAFETY PRECAUTIONS, WHILE ALSO MEETING THE SOCIO-EMOTIONAL AND EDUCATIONAL NEEDS OF YOUTH; BRIDGING THE TECHNOLOGY GAP BY OFFERING YOUTH ACCESS TO COMPUTERS, LAPTOPS, AND TABLETS NEEDED TO COMPLETE SCHOOLWORK; AND OVERALL, PROMOTING SOCIAL AND ECONOMIC EQUITY FOR YOUTH AND FAMILIES WHO ARE STRUGGLING TO MAKE ENDS MEET. AS OF SUMMER 2021, WE RESUMED OUR ALL-DAY SIX WEEK SUMMER DAY CAMP AND PLAN TO RETURN TO STANDARD AFTER-SCHOOL PROGRAMMING IN AUGUST 2021.

BOYS & GIRLS CLUBS OF TUCSON IS COMMITTED TO CONTINUOUSLY AND CREATIVELY RAISING FUNDS AND SECURING IN-KIND SUPPORT TO SUSTAIN OPERATIONS ACROSS ALL SIX OF OUR CLUBHOUSES. THE GENEROUS SUPPORT OF OUR DONORS AND PARTNERS ENABLES US TO KEEP MEMBERSHIP REGISTRATION FEES LOW, AT ONLY \$20 PER SCHOOL YEAR (AFTER-SCHOOL) AND \$60 FOR SUMMER CAMP (SIX WEEKS, FULL DAY). WE OFFER AN EXTENSIVE VARIETY OF STRUCTURED PROGRAMS, FIELD TRIPS, RECREATION/SPORTS LEAGUES, AND OTHER ACTIVITIES. ALTHOUGH THE COST PER CLUB MEMBER TO THE ORGANIZATION IS OVER \$760 PER MEMBER ANNUALLY, NO ONE IS EVER TURNED AWAY DUE TO INABILITY TO PAY THE MEMBERSHIP FEES.

ULTIMATELY, WE BELIEVE THAT CLUB MEMBERS WHO ATTEND FREQUENTLY AND PARTICIPATE REGULARLY IN OUR STRUCTURED PROGRAMS ACHIEVE HIGHER GRADES AND DEMONSTRATE ON-TIME GRADE PROGRESSION AND HIGH SCHOOL GRADUATION, AT HIGHER RATES THAN THEIR PEERS WHO DO NOT ATTEND THE CLUBS.
